Without the contributions of the RGTAG, our industry would face significant challenges, including limited industry consultation, a lack of prioritised trade partnerships, and an absence of critical input during essential protocol negotiation stages. RGTAG plays a pivotal role in facilitating practical and effective communication between the government and the industry, significantly influencing Australia's genetic trade landscape.

RGTAG's importance is exemplified by its efforts to open or reopen trade with countries where live export has declined or been prohibited. This enables producers to continue trading through internationally agreed genetic protocols. Additionally, it provides opportunities for semen companies to market their products overseas when domestic conditions are challenging, such as during periods of low milk prices or adverse weather events.

RGTAG's work enhances the viability of genetics in Australia, achieving outcomes that would otherwise be unattainable.
